### 2. Special Issue on ADHD in American Journal of Medical Genetics

The topic of this issue will be ADHD Genetics focussed on adult ADHD, an IMpACT issue. All IMpACT members have ideas for papers they can contribute to this issue. The deadline for the submission is at the end of September. Barbara will send more information.

### 3. ITN preparation

Companies for collaboration

- Henrik- Swedish company, Scandinavian Development Services, design and registry-based studies.
- Andreas- Eurofins for NGS and statistical analysis, internship of 3 months. They have a similar project running on schizophrenia data.
- ESR2: Nanda and Christine on cognitive biomarkers.
- At some universities students must spend at least 1 year on site to be eligible for a PhD-degree from this university. This might also be the case for KCL. Jonna will explore this.
- A company can be involved in more than one work packages.
- Alejandro will get in touch with Eurofins for ESR7 if no food company can be found.
- If the company gets money this depends how they are involved in the project. If they are involved as a beneficiary, they will get money directly. If they are associated partners, they can get money through the beneficiary that sends its ESR to the company.
- We have 12 beneficiaries. The rule is that 6-10 companies should be involved.

#### International training

- Example: Host of ESR1 is Henrik. A PhD employed by Henrik can be sent out to e.g. Phil
- The rules for the length of a PhD-project might be different per country. In The Netherlands, a PhD-project normally takes 4 years. As only 3 years will be funded by the ETN, one year has to be financed by the PI.

#### Training component

Training is through the research work as well as through courses. These can be existing courses and the ESRs could follow equivalent courses at their own site. All sites have Graduate Schools, for the selection of existing courses for the ETN. Some courses will be designed newly for the ETN. Some will be obligatory, others WP-specific or elective. E-learning and Journal club via internet make collaboration easy between the students.

#### Funding

- Researcher unit costs: this is the salary of the student
- Institutional unit cost: A part of this money will be used for central training. The other part will be used for lab-expenses.

#### People selection

- All students start at the same time, centralized selection with a meeting in month 3. Work package-wise committees for the selection of the students should be formed.
- At KCL you need to pay fees to be a PhD student, Jonna will explore this.

#### **4a.Upcoming Congress: 12<sup>th</sup> World Congress of WFSBP from 14-18 June in Athens**

Contribution from the IMpACT group for this congress by all sites. Andreas and Alejandro will lead this proposal. On this moment we have one speaker from Nijmegen, Norway and Germany. This will be followed up by Alejandro to get more speakers.

#### **4b: IMpACT meeting**
