Plans Brazil 2016

- 1) Acquisition of neuroimaging data from adults with ADHD
- 2) EAT2BNICE (Nutrition/Microbiom project coordinated by Alejandro)
- 3) Gene-level and pathway analyses of ADHD symptoms in adults with ADHD (are being performed by Nina together with the Dutch site)
- 4) Progress on merging and analysing Personality data across IMpACT sites
- 5) Analyses on differences between Persistents vs. remitters – neuroimage, genetics, neuropsychology
- 6) Pharmacogenetics – focus on the role of clinical heterogeneity, starting plans for GWAS and replications in other sites

2.Update projects

A. **RNA project** (Marta, see also info send by mail)

As mentioned in Brazil Marta is recruiting medication-naive adults with ADHD and controls and have detected differences in gene-expression profiles depending on the blood extraction protocol used. Given these results, Marta is now following the second protocol and use CPT tubes for blood collection plus a total RNA (including small RNAs) isolation kit from Qiagen

B. **Personality study** (Claiton/Toni)

The TCI and the NEO instruments were already available in Portuguese and the ZKPQ has now been translated by members of the group as a preliminary/testing version. The 3 instruments are being applied to a population sample (mostly graduate students) as a pilot study in order to evaluate possible analytic approaches.

C. **Adult ADHD GWAS** no news

D. **Microbiome project:** The collection of faeces started in Spain and Brazil. Behavioral data are also collected . The collection method and analysis method needs to be standardized. The Netherlands will serve as replication cohort. Suggestion is to use the IMpACT people from the Psych for the validation of the microbiome results

E. **Other Nina**

Last TC , January 14th Jonna has introduced her new study on the comparison of parent-reported with self-reported ADHD scores. She asked if there was such information present in the IMpACT database.

Nina mentioned that in Brazil they have retrospective data from adult patients about their childhood, both in self-report and in informant-report formats (informants are usually parents/mother). They also have data for current ADHD symptoms as self-report and informant-report (for adulthood, informant are usually the spouse or co-worker). They have published a paper evaluating the self- and informant- concordance: Breda et al. Does collateral retrospective information about childhood attention- deficit/hyperactivity disorder symptoms assist in the diagnosis of attention- deficit/hyperactivity disorder in adults? Findings from a large clinical sample. *Australian & New Zealand Journal of Psychiatry* [in

press] .Jonna is very happy with this dataset, Nina already sent the cited paper to her and they will soon get in touch again..

3. Update on exciting new results coming from individual IMpACT labs to be shared prior to publication.

In Brazil this agenda point was (see summary Brazil)

Several groups have published nice papers on IMpACT-related subjects individually, that others were not aware of. It could be beneficial to share the results or plans with the IMpACT members. We could then find out whether others also have data that could be used, which could improve power and impact of a publication. Sometimes there are good reasons not to include data from other sites, and this fine also, of course, but it might be good to inform the other sites after all. We decide that we will create an item on our monthly TCs to share results/paper plans.

The aim of this agenda point is not to review the paper again but to improve the paper by extra input and knowledge from other sites, to share data. The hands-on people should be involved in this agenda point. Before every TC Angelien will ask the hands-on people for input for new exciting results or a draft version of a new paper.
